1. Rights of Public Entity

NWR reserves the right:

- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing timereferred to in instruction 8 above. A record of the Quotation Opening stating the name of thebidders, the amount quoted, the presence or absence of a Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of price or ownership cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

11. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.
